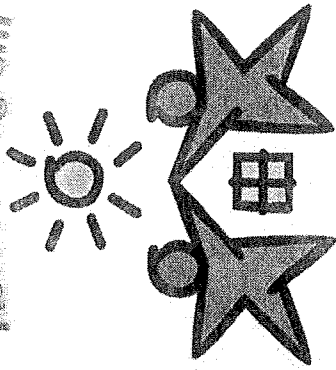

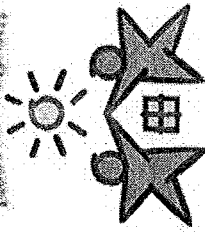

Wayne Children's Healthcare Access Program, WCHAP

- ◆ WCHAP is a Children's Medical Home model building upon the CHAP model in Colorado and the exciting results from the KCHAP Pilot in Kent County, Michigan.
- ◆ The CHAP model provides a Return on Investment for funders, providers, families and the community.
- ◆ The WCHAP Pilot will directly serve 2-500 to 3,000 Detroit-Wayne children in partnership with key pediatric practices, health and social service providers, foundations, policy makers and child health advocates. *Insurance Champions are The Health Plan of MI and Great Lakes!*

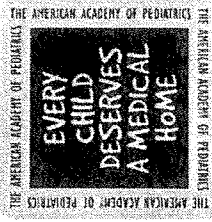
Pilot Goals

1. **Improve** health outcomes, access and quality of care.
2. **Decrease** costs by lowering ER and Hospitalizations.
3. **Increase** well child visits, screenings and cross-system coordination
4. **Impact** systems change w/innovations in policy, funding, professional development and service delivery

Detroit Wayne County Health Authority

- > **Children's Medical Home results in an increase in preventative care and a decrease in ER and hospitalizations.**
- > **North Carolina CHAP has saved \$160 million annually.**
- > **The Colorado CHAP program is now statewide and includes 93% of private pediatricians and provides a Medical Home for 90,000 Medicaid and SCHIP kids.**
- > **KentCHAP in Grand Rapids, Michigan has seen improved health outcomes resulting in a reduction in ED visits and hospitalizations, in addition to an increase in the number of private practice Medicaid slots.**
- > **The WCHAP Pilot has been designed based on data, and input from local and state stakeholders to assure a sustainable and innovative model for improving the health and wellness of our children.**
- > **CHAP is a Public-Private Partnership including funding by Foundations and Medicaid Health Plans.**
- > **The Kresge Foundation has awarded WCHAP a Two Year Demonstration Grant February 2011.**
