How does the program work?

The Energy Efficiency Assistance (EEA) Program teams up with local community organizations to help limited-income DTE customers make energy-saving home improvements at no cost to them. Whether it's replacing old refrigerators or tuning up furnaces and boilers, DTE offers eligible Michigan families practical ways to reduce energy costs. That means stretching household budgets further.

What do the improvements include?

Through your tenant's participation in the EEA Program, the following measures may be installed (this is not an exhaustive list):

- Air sealing
- Insulation
- Energy efficient lighting (LED Bulbs)
- Water conservation equipment
- Energy efficient refrigerator
- High efficiency furnace

Who performs the work?

The program is offered by DTE in partnership with local community action agencies (CAAs) and non-profit organizations (NPOs). These organizations will retain a licensed contractor to provide program measures in your area.

What does this mean for you?

- Energy efficiency improvements to your property are provided at no cost to you or your tenant
- Your property will be more energy efficient and comfortable for tenants
- A licensed contractor will install all measures
- Your property may require less maintenance and your costs may go down as a result

How do I get started?

The first step is to authorize the improvements to be done to your property.

BY SIGNING BELOW YOU, THE PROPERTY OWNER, ACKNOWLEDGE AND AGREE TO THE FOLLOWING:

- The tenant applying for EEA Program participation pays the utility bill(s) for the participating unit.
- You will maintain the items installed under the program in accordance with all relevant codes regarding maintenance.
- Installed equipment may not be removed or altered within 24 months of date of installation.
- You permit the CAA/NPO and its employees/contractors to enter the premises for the purpose of making the improvements.

- You grant the CAA/NPO the right to inspect the premises and examine the completion and quality of the work. You also permit representatives of DTE and its authorized contractor, SEEL LLC, to inspect the premises to ensure the work meets the program’s guidelines.
- You will surrender any equipment (i.e. refrigerator, furnace) deemed eligible for replacement with a high efficiency unit.
- YOU AGREE THAT DTE IS NOT RESPONSIBLE FOR THE SELECTION OR INSTALLATION OF ANY ENERGY EFFICIENCY MEASURES. FURTHER, YOU ACKNOWLEDGE THAT DTE ASSUMES NO RESPONSIBILITY FOR OVERSIGHT OF CONTRACTOR SERVICES OR FOR ANY CLAIMS THAT YOU OR THE CUSTOMER MIGHT HAVE AGAINST THE MANUFACTURER, RETAILER OR CONTRACTOR INSTALLER WITH REGARD TO THE ENERGY EFFICIENCY SERVICES OR MEASURES IMPLEMENTED. ACCORDINGLY, YOU HEREBY RELEASE AND FULLY DISCHARGE DTE FROM ANY AND ALL CLAIMS, LIABILITIES OR OTHER COSTS OR EXPENSES ARISING OUT OF THE CUSTOMER’S PARTICIPATION IN THE PROGRAM. YOU FURTHER ACKNOWLEDGE AND AGREE THAT DTE MAY, WITH CUSTOMER’S PRIOR AUTHORIZATION, USE, SHARE OR STORE THE ENERGY USAGE DATA FOR THE SUBJECT PROPERTY.
